RULES AND REGULATIONS

The rules of the RE/MAX Derby hereinafter described shall be binding on both contestants and sponsors. The Derby Judges shall have the power to make final decisions in all matters pertaining to the Derby, including, but not limited to, eligibility, time limits, weights, measure, contestant's participation and overall conduct of the Derby. Decisions rendered by Derby Judges shall be final and conclusive.

Wavier of Liability: All entrants shall recognize that their signature on the Derby registration form constitutes a waiver of liability holding harmless RE/MAX

Associate Brokers and its officers and directors and employees, Safe Harbor Clinic and its officer and its directors and employees, and all sponsors of the Derby, from any and all claims of liability, injury, loss of life, loss of property or damages of any kind arising from their participation in the RE/MAX Associate Brokers CRAB DERBY. Further, by registering for the RE/MAX CRAB DERBY each participant accepts sole responsibility for their own safety and affirms their ability to be aware of their surroundings and take appropriate actions to safeguard themselves.

***Eligibility to Enter:* Any man, woman or child at least 11 years old and competent to read and comply with these rules shall be eligible to enter the RE/MAX CRAB DERBY. Entrants under age of 18 must be accompanied by a parent or guardian who shall sign the registration along with minor.**

Prizes will be awarded as follows:

**FIRST PRIZE: Largest weigh in of maximum two man team; (total 10 crabs)
\$1,000.00**

**SECOND PRIZE: 2ND largest weigh in of maximum two man team (total 10 crabs)
\$350.00**

**THIRD PRIZE: 3RD largest weigh in of maximum two man team (total 10 crabs)
\$150.00**

LARGEST OVERALL CRAB MEASURED FROM POINT TO POINT : \$300.00

Qualifications:

1) Anyone wishing to enter the Derby must fill out an application and pay \$50 per person/ or two man team by July 15th 2017. A maximum of 60 participants/ teams will be accepted. Each person/ or two man team will receive 3 raffle tickets per application for drawing being held at Derby day.

2) When weighing in your crab, you must show valid identification along with current crab license. If participant is a two man team, both team member must have valid crab licenses. All crab must be alive and brought to the weigh station via water.

3) Weigh station and Derby day will be held at Camano State Park at the Party House. You may arrive by boat or car. All participants must follow the Park's rules and regulations.

4) No one participant or team may win both prizes.

Weigh-In Station Times: The weigh in station at Camano State Park will be open from 11:00 AM until 6:00 PM on DERBY day, July 22nd, 2017. All participants need to have their weigh-in completed no later than 6:00 PM.

In the Event of a Tie: The person/ or two man team who enters first for weight and size shall be deemed the winner.

Disqualification: Any contestant who brings to the weigh station a crab that has been altered in any manner will be disqualified. Failure of a contestant to conduct him or herself in a sportsman like manner during the Derby, in the sole discretion of the Derby Judge shall be disqualified. In the event of a disqualification there shall be no refund of registration fees.
